Technical part

STAGE 1: blockchain

As we treat every client individually, before any code/contract/token is created, we have to create working token and cash flows

- analyse business model, user needs
- determine the technology that can be used to meet that model/needs
- web3 is essential, when we meet smart-contracts, it needs to be integrated
- NTF tokens can be used, but not always are need custody solution can be helpful if part of the users are not familiar with the blockchain/crypto world
- work on details, build user stories, prepare the data needed to create contracts

Realization time: up to 3 weeks

STAGE 2: smart contracts

We create a contract for project needs, depending on business logic and tokenomics build. Typical elements can include:

- ERC20 token contract based on well-known and tested OpenZeppelin code, including newest ERC2612 and ERC3009 extensions
- Fundraising contract (buy tokens directly through the contract) with parameterization of the process parameters
- Vesting contract - time-lock tokens for early investors to protect the project economy
- Stacking contract - allow users to time-lock tokens for rewards

OAAM provides also IT consultation

OAAM will provide a complete solution with IT services. We will create:

- payment platforms with KYC AML verification
- NFT galleries
- marketplace for solutions in Metaverse

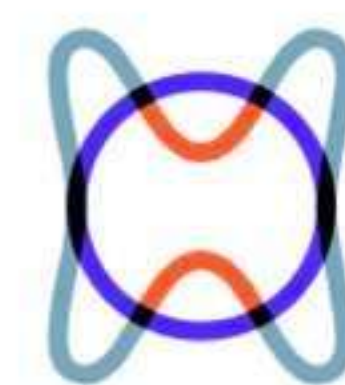
